#### **ELIGIBILITY:**

- 1. Valley members and spouses with established Valley handicaps are eligible and will have priority to join.
- **2.** Entries will be prioritized on a "first come, first served" basis as determined by the Registration Forms, which will be numbered as they are received.
- 3. **DEADLINE for Members to Sign-Up** will be on Sunday, April 08, 2018, at 5:00 P.M. Members lose priority after the aforesaid deadline.
- 4. Dependents will be accommodated only if there are still slots available. There will be a separate sign-up sheet for dependents.

#### **SIZE OF FIELD:**

- 1. Members must register, preferably in person, at the Registration Desk.
  - a. Verbal Registration by phone will NOT be entertained.
  - b. Unsigned registration forms will NOT be accepted.
  - c. Faxed copies are acceptable. (Fax Nos. 658-4918, 658-4919 & 658-0079)
  - d. Signed entry forms sent via email are acceptable. (info@valleygolf.com.ph)
    - PLEASE LABEL FAXES "ATTENTION: LANI LAYCO."
- 2. Teams must indicate their preferred playing dates (Set 1, Set 2, Set 3 or Set 4) on the Registration Form. Forms will be available starting January 20, 2018 at the Registration counter at the Valley Golf Main Clubhouse, Tel. No. 658-4901 to 03.
- 3. In case the team can not be accommodated on the playing dates they had chosen, tee-off assignments will be made on a "first come, first served" basis (as determined by their registration numbers).

## **ENTRY FEE:**

**PhP12,000.00 per team**. This fee covers the giveaways for each participant, dinner at the Awards Night, participation in the raffle, and two practice rounds (one for each course) for the guest.

## **FORMAT:**

The tournament is a 36-hole two-player team competition. (One member and one guest) The Rules of Golf as approved by the R&A Rules Limited, the USGA, along with the existing VG Local Club Rules and other Tournament Rules for this particular tournament will apply.

# **HANDICAPPING:**

- 1. Club members will use their **February 2018** Valley Golf Handicap . <u>Maximum handicap allowed for members</u> <u>for the tournament will be 36.</u>
- 2. Guests must submit their handicap for February 2018 (in case of multiple handicaps, they must submit whichever is lower. Maximum handicap allowed for guests for the tournament will be 25).
  - It is the Valley member's responsibility to submit his guest's **February 2018** <u>verifiable</u> handicap certifications. Handicaps must be certified by USGA/R&A accredited clubs using UNHS handicap certifications issued by USGA accredited clubs.
- 3. Teams participating in the Sponsor's division shall compete under the System 36 Scoring System.

#### SCORING:

Stableford (PAL) Point System, NET OF HANDICAP.

(In case of ties, please refer to the 19<sup>th</sup> DCT Cup Rule Book.)

#### **PAIRINGS:**

Absolutely no requests for flight mates will be accepted.

#### TEES:

Men will tee-off from the BLUE TEES.

Ladies will tee-off from the RED TEES.

Age 60 and above male players will tee off from the WHITE TEES.

# **CLASSIFICATION:**

- 1. The number of divisions will be determined based on the number of teams entered.
- 2. Teams will be classified based on the member's handicap.
- There will be a separate division for sponsors and their guests. If a sponsor or his partner is a member of VGCCI, they have the option to compete in the regular divisions.
- 4. Two members, dependents or a combination of both may NOT form a team.

#### PRACTICE ROUNDS:

Guests will be issued two (2) green fee coupons, one (1) for the South Course and one (1) for the North Course, valid until **15 August 2018.** 

- <u>SOUTH COURSE</u>: Coupon may be used only on weekdays (except on holidays). **Guests must be** accompanied by a member per flight.
- NORTH COURSE: Coupon may be used anytime. Guests need not be accompanied by a member.
- Guests may opt to combine both South and North green fee coupons to be able to play the South Course on a weekend or holiday. And should be accompanied by member.

#### **PILIGANS:**

Piligans are mandatory at Php 500 per playing day. (Can be used anytime, i.e. 2 in one hole). Piligans may be used anywhere **except on the putting green**. All players <u>must declare</u> their intent to their competitor(s) before using their piligan. As per definition, "PILI" the player may choose his/her better shot after using his/her **Piligan**.

**Note:** Upon declaration, a "Piligan" is deemed used even if the original ball was chosen upon taking the "Piligan". Failure to declare the intent to use the "Piligan", the 2<sup>nd</sup> ball shall be deemed to be ball in play and shall incur a penalty of stroke and distance.

#### **CADDIE FEE:**

The minimum Caddie Fee for the tournament is **Php500** per 18 Hole round.

# BOTH PILIGANS AND CADDIE FEES MUST BE PAID UPON REGISTRATION ON EACH PLAYING DAY. START DATES/ DEADLINES:

Last Day for submission of the partner's name and their handicap.

(Guests without handicapwill be given a "0" handicap.)

Last Day for any change in partners.

Last Day for Members to sign up.

Last Day for All WITHDRAWALS - After this date, your accounts will be charged the full tournament fee. The member will still receive the giveaways and his name will be included in the raffle. All withdrawals must be made in writing. All requests for withdrawal must be accomplished in duplicate with one copy going to the tournament committee and the other to the member (as proof of his/her backing out). Verbal requests for withdrawal will not be entertained. If the guest has played at least one (1) practice round, the member will be charged the full tournament fee.

Dependents may be accommodated subject to availability of slots. There will be a separate sign-up sheet for dependents. Members lose their priority after the aforesaid deadline.
